## **EXECUTIVE SUMMARY**

The Wisconsin Department of Natural Resources (WDNR) was tasked with implementing the recommendations contained in the June 2012 Deer Trustee Report (DTR) submitted to the Wisconsin Department of Administration by a three person Deer Trustee Committee led by Dr. James C. Kroll. The overarching goal of the report was to enhance white-tailed deer hunting, management and research in Wisconsin through improved communication and by addressing areas of concern expressed by the hunting public and further involving them in the decision-making process.

As the initial step in the implementation process, 62 recommendations from the DTR Executive Summary were categorized into five consistently-themed groupings identified as follows:

- Deer Management Assistance Program (DMAP)
- Herd Health/Chronic Wasting Disease (CWD)
- Regulations & Season Structure
- Science & Research
- Administrative


The first four groupings as listed above were assigned to publicly-driven Action Teams consisting of volunteers from around the state. Participation on the Action Teams was open to any member of the public representing themselves, or as a representative of an organization. The Action Teams were formed following a March 9, 2013 public meeting held at the University of Stevens Point, Dreyfus University Center, Stevens Point, Wisconsin. The purpose of each Teams was to review and digest the background information related to the recommendations of the DTR and develop implementation proposals for the Department to consider when drafting administrative rules.

The Administrative group of recommendations were assigned to internal WDNR Action Teams as some of these recommendations were significant enough to require an independent public involvement process, involved internal process or were simply statements that did not require further public refinement.

As with many natural resource oriented issues, several of the recommendations were not standalone issues as any change in one area would have ramifications to other aspects of deer management. As a result, there were a number of recommendations that did not fit exclusively into one Action Team over another and were assigned to two Teams to consider.

The formation of the Action Teams was part of a larger WDNR effort to process and implement the recommendations contained in the DTR. After the release of the DTR in 2012, the WDNR developed a DTR Implementation Approach that was approved by the Deer Trustee, tribal interests, and representatives from several deer management stakeholder group. It identified four sponsors from WDNR Administration to oversee the effort, assigned a DTR Implementation Coordinator to coordinate and lead the effort, and formed an eleven member Core Team of WDNR staff plus tribal representation to assist the public Action Teams.



To help facilitate the Action Team meetings, the WDNR contracted with two Wisconsin-based firms to provide independent third-party facilitators to assist with meeting planning, providing visual aids and maintaining a positive and productive meeting environment for team members to discuss and deliberate alternative implementation proposals.

The complete Action Team meeting schedule was approximately every third Saturday starting April 6<sup>th</sup> and concluding July 20<sup>th</sup>. The schedule including the initial March meeting is below:

As of June 8<sup>th</sup>, the four public Action Teams have developed and submitted **33** implementation proposals addressing 39 of the 49 recommendations.



## **Next Steps**

Early in the formation and orientation process, the WDNR explained to Action Team participants that the implementation proposals submitted represented a <u>starting point</u> for the lengthier process of making administrative rule and legislative changes to white-tailed deer management in Wisconsin. The 'roadmap' graphic below was used to illustrate this point.

Thus, when reviewing the proposals submitted, it should be with the understanding that the Action Team's efforts were focused on developing *concept-driven* ideas for implementing the DTR recommendations rather than creating detailed administrative rule language or guidance for legislative changes to deer management practices.

## Summary

The DTR Action Teams have three meetings remaining to finalize and submit their proposals for implementing the recommendations. Although all of the implementation proposals have the potential to garner significant public interest and discussion, especially when considered collectively, a couple of noteworthy proposals include:

- Simplify the hunting season structure with the creation of 5 hunting zones.
- Encourage legislative action to ban baiting and feeding of deer statewide.
- Eliminate free antlerless tags and recommend allowing hunters to purchase them in groups of 3 tags.

- Adopt a "more passive" approach in the CWD Management Zone however continue to focus on deer population reduction to control the spread.
- Initiate a Deer Management Assistance Program with a preliminary list of mechanisms to include:
  - o On site visit by a wildlife biologist and forester (initial visit/consultation is free)
  - Informational packet of DMAP related materials to be given on initial consultation. Information should be current, detailed, and relevant to deer management and DMAP.
  - o Instruction on wildlife inventory and monitoring resources
  - o Collection and reporting of biological harvest data
  - o Annual renewal should be contingent upon submission of biological harvest data
  - o Annual meetings
  - Media be used at its full potential (online, print, broadcast media, blog, YouTube videos, popular articles, sport shows, etc)
  - DMAP should be used on public lands w/ antierless permit allocation as part of the public lands aspect
